



In 2011, ART 180 provided opportunities for creative expression to 350 young people in the Metro Richmond area through thirty 12-week after-school programs and a summer public art project. The unique program offerings, developed by local artists in partnership with ART 180, spanned visual, performance and literary arts. In the winter we showed off our young artists' work at our Open Studio Series, exhibiting and performing live in three locations, on three nights, across Richmond. In the spring we gathered and wowed our largest crowd to date at The Big Show, where we celebrated a year of programs. Two mural projects shared the voices of our young people in dynamic public settings. Artists from George Wythe High School created a vibrant piece about compassion outside the Positive Vibe Café, a nonprofit restaurant that provides training to young people with disabilities. The Salvation Army Boys & Girls Club offered the setting for another mural, where the artists illustrated their creative and community spirit with a playful collage of colorful images. Our hip hop program at Henderson Middle School (one of several ART 180 partnerships with Communities in Schools of Richmond) challenged young people to put their own spin on this popular art form. This group brought down the house at The Big Show with their energetic performance of original rhymes and dance. The artists at

Boushall Middle School acquired a variety of new skills through the medium of film. In the spring, they interviewed members of the Boushall community to create a powerfully honest documentary about life at the school. The fall semester project introduced the young people to stop-motion animation, which they used to create a touching yet humorous film about the timeless struggle between the forces of good and evil. This year marked a new chapter for SOHO Space of Her Own, a program developed over the past three years with the Visual Arts Center of Richmond. ART 180 launched a program for SOHO alumni in the fall at Friends Association for Children, where each girl continued to discover and use her voice through writing and spoken word. Our summer project asked using 6th graders What Do You Stand For? and guided them in the creation of 8-foot-tall self-portraits as part of Higher Achievement's inaugural summer academy in Richmond. The resulting installation travel to sites across the City throughout 2011 and the first half of 2012, sharing with others the people, ideas and dreams that give these young artists purpose. We moved one step closer to our own dream of a youth-driven downtown art center with the establishment of an ART 180 alumni program. This group consists of teens with a passion for our mission and the leadership potential to engage other youth. Their first project was a documentary film investigating attitudes toward the First Fridays Art Walk and how young people-and young artists-can contribute positively to our community.
