The Girls Write Now mission is to provide guidance, support, and opportunities for at-risk and underserved girls from New York City's public high schools to develop their creative, independent voices, explore careers in professional writing, and learn how to make healthy school, career and life choices

Distinguished as one of the top 15 after-school arts and culture programs in the nation by The President's Committee on the Arts & the Humanities, Girls Write Now (GWN) is the first organization in the United States to combine mentoring and writing instruction via all-girl programming. We primarily serve young women of color from low-income neighborhoods, with the goals of helping them gain increased literacy and communication skills, fostering personal growth and a positive self-image, exposing them to various writing genres and the craft of writing, and providing them with confidence and experience in public speaking and leadership activities. The Girls Write Now mission is to provide guidance, support, and opportunities for at-risk and underserved girls from New York City's public high schools to develop their creative, independent voices, explore careers in professional writing, and learn how to make healthy school, career and life choices. GWN seeks to address a myriad of interconnected, systemic, gender-based issues, including the underrepresentation of women's voices in the public sphere, disparity in the classroom, lack of visible role models for women writers (especially minority women), and the need for young women to be provided with leadership opportunities. In a city where 40% of high school students fail to graduate on time, and only 31% were shown to have proficient writing skills, Girls Write Now helps fill a critical gap caused by severe cuts to arts and writing instruction and services, overcrowded classrooms, and a narrow focus on improving test scores. GWN engineers one to one matches between teen girls and professional women writers-published authors of renowned publications and educational institutions-who become their tutors, role-models, and inspirations-building together a one to four year-long mentorship. Our demographics reflect New York City's rich diversity, as over 90% of the students we serve are girls of color, 20% recent immigrants, and 67% qualify for a free lunch. Most of the girls we serve participate in our Mentoring Program, which runs concurrent to the school year. A rigorous enrollment process launches in the spring and the class is selected by fall, at which time mentee and mentor are paired based on interests, location, and needs. Throughout the year, Girls Write Now produces 10 events that form the curricular backbone of the program, including an orientation, three training sessions, and 6 dynamic, conference-sized workshops that each focus on a sub-genre of our core offerings (fiction, poetry, memoir, screen- or play-writing, journalism, and "wild card"). Weekly throughout the year, each mentor-mentee pair meets for one to two hours to extend and customize the lessons learned in workshops, learn the editing process, and build out their six-genre developmental writing portfolio. These sessions culminate in polished, original pieces published in the annual Girls Write Now Anthology, and publicly performed at major cultural venues in our acclaimed spring reading series, CHAPTERS. Ancillary programming includes expanded college preparatory services and seminars, as well as pro bono mental health support from a panel of licensed therapists. Organizational successes are evidenced by the 100% of our seniors who graduate high school and matriculate in college, our uncommonly high retention and return rates in a demanding program (over 90% within the year, with return rates for non-seniors over 80%), our mentees' robust participation in the Scholastic Arts & Writing Awards (25 Regional Gold and Silver Keys and 2 National Awards won in 2011), the prestigious array of honors and scholarships earned by mentees, and the program's growing wait lists (often triple what we can accommodate) for both mentors and mentees.
