The Foundation does not engage in extensive fund raising activities but, does have a continuing program to remind the Church's congregation and other interested parties of opportunities to assist through contributions to the Foundation. Resources are provided to the Foundation through numerous small contributions in the range of \$25 to \$500 and infrequent larger contributions and bequests of \$5,000 or more. The fluctuating levels of contributions and the relatively large portion of restricted principal funds means that investment income usually represents a substantial portion of the funds available for grants and loans. Investment income and contributions are subject to considerable fluctuation from year to year depending upon the economic climate and the securities markets as well as the level of and generosity of contributors. Consequently, calculated "public support" may often be less than 33.3% of total support.
