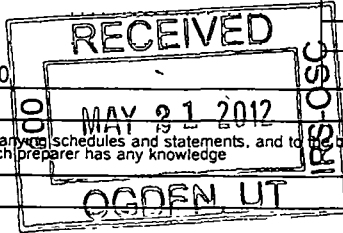

Housing Program: Volunteer work teams completed 21 home repair projects and constructed 3 new homes for low-income families in Barbour County, WV, between May and August 2011. The goal of the program is to improve living conditions by making homes safer and reducing over-crowding.

4b (Code) (Expenses \$ 43,899. including grants of \$ 0.) (Revenue \$ 25,360.)

Garden Market: This program provides facilities and management where individuals can market and purchase locally grown produce in Barbour County, WV. There were 85 participating growers in 2011. The market benefits low-income families by (1) allowing them to supplement their income with proceeds from sales of produce they grow and (2) by supporting the use of SNAP EBT and WV Farmers Market Nutrition Program coupons for low-income buyers.

4c (Code) (Expenses \$ 42,914. including grants of \$ 11,661.) (Revenue \$ 0.)

Emergency Assistance: In 2011, we provided assistance to 1,518 low-income households in Barbour County, WV; including food, infant care items, hygiene items, household cleaning items, and financial assistance with past-due utility bills, prescription expenses, and rent.
