Friends of Blackwater continues to work to protect the federally owned Blackwater Canyon Rail Trail. We made and distributed trail maps and have them on our website. We pressured the Forest Service to put interpretive signage along the Rail Trail and they put a nice kiosk with benches and signage about the early coal and coke industry along the Trail in downtown Thomas. Signs are also being developed for the coke ovens in Coketon. We worked with film maker Nora Sheridan to have a video made of Blackwater Falls State Park. The video won a national prize and is on YouTube

Friends of Blackwater won their lawsuit to return "Ginny", the rare West Virginia northern flying squirrel to the endangered species list. Ginny is the most unique mammal of the Allegheny Highlands and the signature species of Blackwater Canyon. On Friday, March 25, 2011, Federal Judge Emmett Sullivan vacated an August, 2008 rule issued by the United States Fish and Wildlife Service that removed all Endangered Species Act (ESA) protection for "Ginny," and restored federal legal protection for this small nocturnal resident of West Virginia's highest mountains. Under this program we also advocate for the little brown bat, threatened by white nose syndrome and other rare species of West Virginia. We advocated for studies on bats in Blackwater Canon caves. The studies revealed that bats there were dying from white nose syndrome. We also reported on threats to the golden eagle from industrial wind turbines and advocated for stronger regulation to protect all avian species threatened by this new industry.

This project was created in 2002 to improve this gateway to the Blackwater Canyon. The North Fork flows along the Blackwater Canyon Rail Trail and is negatively impacted by acid mine drainage pollution. The Project presented programs on water quality and trail building along the river to students, community groups, Boy and Girl Scouts and 4-H Clubs. The Project worked with the town of Thomas to build a trail system in the Thomas City Park along the North Fork. Our Vista Volunteers and employees monitor water quality in the North Fork with volunteer help. We continued to monitor headwater streams that flow through Blackwater Falls State Park to analyze their potential for remediation and native brook trout reintroduction. The North Fork staff also attended events and gave out maps and history brochures on the area.

We created a poster and coloring book about the life of J.R. Clifford including his famous Blackwater Canyon civil rights case of 1894 for all the elementary school teachers in the state. To honor the State's 150th birthday, we created and put on a living history drama: "A New Home for Liberty, Human Rights, Slavery and the Creation of West Virginia". The play was put on in Charleston and Morgantown. Scholars took part in the programs and commented on the Civil War period. Approximately 1,500 people attended the drama and legal seminars and schools programs built around the play.

Friends of Blackwater has advocated for a national park in Blackwater Canyon and the surrounding area since we were founded in 2000. A core group of volunteers recruited folks to ask Senator Manchin to request a Reconnaissance Study for the Park. The Senator made this request and the Park Service agreed in November. We used our website, Facebook page and E-News to educate our membership about national parks.

Friends of Blackwater set up the Eastern National Forests Gas Drilling Working Group and joined with three other national forest advocacy groups to review and object to problematic gas drilling proposals on these public lands.
