FOR FINANCIAL STATEMENT PURPOSES, THE RESULTS OF OPERATIONS FROM THE INFUSION THERAPY ACTIVITY FOR THE PERIOD JANUARY 1, 2011, THROUGH MARCH 21, 2011, HAVE BEEN RECOGNIZED AS DISCONTINUED OPERATIONS.
