OVER 400 PEOPLE ATTEND THE EVENT, WHICH INCLUDED A MEAL, SILENT AUCTION, AND AUCTION OF THE TOP JUNIOR LIVESTOCK ENTRIES. THE PROCEEDS FROM THIS EVENT ALLOWED THE FOUNDATION TO RETURN OVER \$57,000 IN SALES PROCEEDS TO YOUTH LIVESTOCK EXHIBITORS.
