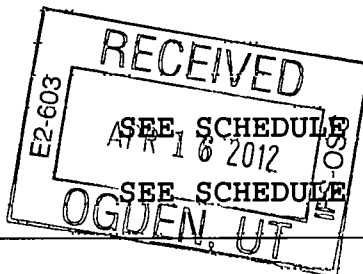

Students . . . committed to improving lives each day

R.A.M.P.S. (*Ramp Access Made Possible by Students*) is a non-profit 501 (c) (3) community service organization based in Richmond and dedicated to aiding those in our community who cannot help themselves. RAMPS develops compassionate young adults through an innovative program that works with high school and college age students. These volunteers donate their time to build modular wheelchair ramps for the disabled and elderly people in our community who rely on a wheelchair or walker for mobility, but cannot afford a ramp to get them safely in and out of their homes.

The target population for RAMPS is low-income, and either elderly or disabled (of any age). From 2005 to now, over 380 student volunteers from 23 different high schools and colleges have donated over 4,000 hours to improve the lives of these individuals by providing access to the outside world via 148 wheelchair ramps.

As a direct result of the service to the community, these students have enabled wheelchair-bound elderly ramp recipients to return to homes they could not safely access without a ramp. In three cases, caregivers no longer need to call the local rescue squad to move individuals in and out of their homes. This benefits the community at large as the rescue units are not "off-line" helping these disabled individuals.

All of the ramps allow the recipients to regain access to regular medical care and their various support systems. In addition, these individuals stay in their homes for longer, reducing housing turnover in old neighborhoods. Some of the ramp recipients enjoy speaking with the students as they build the ramps, and many cry tears of joy on their first trip down their own ramp. In the words of one woman, "I just never knew anybody cared. I never expected anyone to do something so wonderful for me."

RAMPS is innovative and collaborative in their business model. We work with existing social services and other non-profits, such as project HOMES, to avoid duplication of effort. RAMPS supports active civic engagement through the wheelchair ramps we build and is a prime example of connecting communities and schools to their mutual benefit. The program provides an excellent opportunity for intergenerational discourse.

The modular ramp system used by the group allows the ramps to be recycled to the home of other needy individuals. In fact, RAMPS recycled almost \$50,000 worth of materials in 2011 (\$24,000 in 2010), allowing them to keep pace with builds. Keeping a steady stream of donations is always a challenge, especially for the students since they are responsible for raising a portion of the funds as a part of their learning experience
