At December 31, 2011 and 2010, there was a federal net operating loss carryforward of \$238,013 and \$335,617,

respectively, and a state net operating loss tax carryforward of \$176,929 and \$274,533, respectively. The net operating loss carryforwards begin to expire in 2025 for federal purposes and 2020 for state purposes.

NCAR's wholly-owned subsidiaries are subject to federal and state corporate income taxes. At December 31, 2011, NCAR Service Corporation had a federal tax liability of \$59. At December 31, 2011 and 2010, the for-profit subsidiaries had federal net operating loss tax carryforwards of \$0 and \$1,420,374, respectively and various state net operating loss tax carryforwards of \$0 and \$1,239,101, respectively. The net operating loss carryforwards begin to expire in 2023 for federal purposes and 2019 for state purposes. The for-profit subsidiaries have not established a deferred income tax asset due to the uncertainty surrounding the realization of such an asset.

The organization's policy is to evaluate all tax positions to identify those that may be considered uncertain. All identified material tax positions are assessed and measured by a "more-likely-than-not" threshold to determine if the benefit of an uncertain tax position should be recognized in the financial statements. For the year ending December 31, 2011, there were no uncertain tax positions.

The tax returns for the organization and its subsidiaries for the years ending 2008 through 2011 are subject to examination by the Internal Revenue Service and the North Carolina Department of Revenue, generally for three years after they are filed.
