


3. APPLICANT MUST HAVE BEEN ACCEPTED TO A SCHOOL OF HIGHER LEARNING IN PURSUIT OF A DEGREE OR CERTIFICATION, SPECIFICALLY A COLLEGE, UNIVERSITY, OR TECHNICAL INSTITUTE. APPLICANT MUST COMPLETE AND SIGN HIS OR HER OWN APPLICATION.
