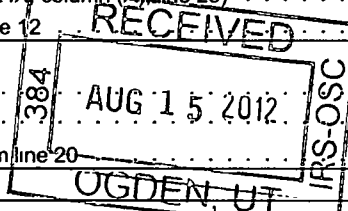

WNCA's core program areas are citizen engagement, public lands, water, and land use. Our work in 2011 included: (1) negotiating with the U.S. Forest Service on several proposed timber sales to protect old growth areas and reduce road incursions; (2) controlling invasive, exotic plants in several areas on public lands to protect threatened or endangered plants; (3) planning for the reintroduction of fire as a management tool in parts of WNC; (4) preparing approaches to chronic wastewater discharge permit violators to address the violations; (5) identifying erosion problems on national forestlands; (6) engaging in bacteria monitoring on the Swannanoa River to identify and stop pollution sources; (7) advocating improved monitoring and remediation of ground water pollution around coal ash ponds; (8) planning for the French Broad River paddle trail; (9) hosting a 9-day paddle down the French Broad River; (10) managing the Environmental Quality Institute and testing water samples from
