THE WEEK IS COMPRISED OF A SERIES OF WORKSHOPS INCLUDING COMMUNICATION SKILLS, CONFLICT RESOLUTION, REFLECTIVE LISTENING, DRESSING FOR SUCCESS, INTERVIEWING SKILLS AND JOB RETENTION. IN ADDITION, EACH PARTICIPANT RECEIVES A ONE-ON-ONE SKILLS ASSESSMENT WITH AN EMPLOYMENT COUNSELOR.

UPON COMPLETION OF THE WEEK-LONG CLASS, EMPLOYMENT COUNSELORS ASSIST ALL GRADUATES WITH POTENTIAL EMPLOYMENT. STEPUP CURRENTLY WORKS WITH OVER 160 EMPLOYERS AND MATCHES APPLICANTS WITH THE TRAINING, EXPERIENCE AND INTERPERSONAL CRITERIA REQUESTED BY AN EMPLOYER.
