The Center's purpose is to promote awareness of the value of meditation, contemplation and silence as a way to uncover the truths within the heart. During the year the Center conducted 25 meditation retreats varying in length from 2 to 7 nights, for a total of 102 retreat-nights. The retreats were conducted by 30 teachers and attended by 561 participants. Teachers primarily represent a variety of Buddhist traditions, but also included other offerings. Attendees taking advantage of scholarship offerings totaled 48, or approximately 9% of attendees.
