Pursuant to § 55A-10-06 of the North Carolina General Statutes, the undersigned corporation (the "**Corporation**") hereby submits these Articles of Restatement for the purpose of restating its Articles of Incorporation and also for the purpose of amending its Articles of Incorporation:

1. The name of the Corporation is North Carolina Citizens for Business and Industry Foundation, Inc.
2. The text of the Restated Articles of Incorporation is attached hereto as Exhibit A.
3. The Restated Articles of Incorporation were adopted by a sufficient vote of the board of directors of the Corporation on May 9, 2008.
4. The Restated Articles of Incorporation contain an amendment not requiring member approval. Member approval is not required because the Corporation does not have members.
5. Pursuant to § 55A-10-30 of the North Carolina General Statutes, the Restated Articles of Incorporation contain an amendment requiring approval by a two-thirds vote of the entire membership of the Executive Committee of the North Carolina Chamber, a North Carolina corporation formerly named North Carolina Citizens for Business and Industry, Incorporated. Such approval was obtained.
6. These Articles of Restatement shall be effective upon filing.



**RESTATED ARTICLES OF INCORPORATION
OF
NORTH CAROLINA CHAMBER FOUNDATION**

Pursuant to § 55A-2-02 of the North Carolina General Statutes, the undersigned corporation (the "**Corporation**") hereby submits these Restated Articles of Incorporation:

1. The name of the Corporation is North Carolina Chamber Foundation.
2. The street address and county of the registered office of the Corporation is 701 Corporate Center Drive, Suite 400, Raleigh, Wake County, North Carolina 27607.
3. The mailing address of the registered office of the Corporation is Post Office Box 2508, Raleigh, North Carolina 27602.
4. The name of the registered agent of the Corporation is S. Lewis Ebert.
5. The street address and county of the principal office of the Corporation is 701 Corporate Center Drive, Suite 400, Raleigh, Wake County, North Carolina 27607.
6. The mailing address of the principal office of the Corporation is Post Office Box 2508, Raleigh, North Carolina 27602.
7. The Corporation will have no members.
8. The Corporation is organized and is to be operated exclusively as a charitable and educational organization within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "**Code**"), or the corresponding section of any future federal tax code. In furtherance of such purposes, the Corporation may engage in any lawful activity except as restricted herein.
9. The Corporation is not organized for profit. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 8. The Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Code, or the corresponding section of any future Federal tax code.
10. In the event of termination, dissolution or winding up of the Corporation in any manner or for any reason whatsoever, all of its remaining assets, if any, after the payment, discharge or satisfaction of all of its liabilities and obligations shall be distributed to (and only to) one or more

organizations selected by the Board of Directors of the Corporation which supports the purposes for which the Corporation was formed, to be used for the purposes for which the Corporation was formed, which organization or organizations shall qualify under Section 501(c)(3) of the Code, or the corresponding section of any future Federal tax code. Any such assets not so distributed shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

11. To the extent consistent with the requirements for qualification as a tax-exempt corporation described in Section 501(c)(3) of the Code, or the corresponding section of any future Federal tax code, and except as otherwise provided herein, to the fullest extent permitted by applicable law no director of the Corporation shall have any personal liability for monetary damages arising out of any action whether by or in the right of the Corporation or otherwise for breach of any duty as a director. This Article shall not impair any right to indemnity from the Corporation or any other immunity from civil liability that any director may now or hereafter have. Any repeal or modification of this Article shall be prospective only and shall not adversely affect any limitation hereunder on the personal liability of a director with respect to acts or omissions occurring prior to such repeal or modification.

12. Pursuant to § 55A-10-30 of the North Carolina General Statutes, all amendments to these Restated Articles of Incorporation require the approval of a majority of the entire voting membership of the Executive Committee of the Board of Directors of the North Carolina Chamber, a North Carolina corporation, and if there be no such Executive Committee the approval of a majority of the entire voting membership of the Board of Directors of the North Carolina Chamber, in addition to such approval of the Board of Directors of the Corporation as may be required by Chapter 55A of the North Carolina General Statutes.
