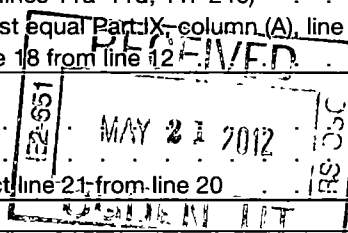

Agape Way regularly and consistently monitors and enforces compliance with the conflict of interest policy by reviewing transactions for potential conflicts of interest / related party transactions and the Board of Directors is updated on the results.

Form 990 Part VI, 15a and 15b:

Agape Way reviews and approves the CEO's compensation annually through independent persons, comparability data and contemporaneous substantiation through an annual review process. The Board reviews and approves the compensation for CEO and key employees.
