

The program provides limited financial and legal oversight for an independent artist or group of artists for a one-time project or on-going program or a start-up arts organization that is pursuing its own 501(c)(3) status.

In 2011, Positive Space worked with two sponsored artists/groups:

Weathervane Music, to build a community of fans and musicians around Shaking Through, a project that documents the recording of a song. Gospel of Rutba, a film about encounters, understanding, and peace in Iraq.
