THE HOMEOWNERSHIP RESOURCE CENTER (HRC) PROVIDES FINANCIAL LITERACY EDUCATION AND COUNSELING TO PRIMARILY LOW TO MODERATE INCOME INDIVIDUALS AND POTENTIAL HOMEOWNERS. THE HRC PROVIDES COUNSELING TO INDIVIDUALS FACING FORECLOSURE AS WELL AS EDUCATIONAL WORKSHOPS FOR POTENTIAL FIRST TIME HOMEBUYERS. IN 2011, THE HRC EDUCATED OVER 790 INDIVIDUALS, ASSISTED 48 TO PURCHASE HOMES, AND PROVIDED COUNSELING TO OVER 2,600 INDIVIDUALS FACING FORECLOSURE. THE HRC WAS ALSO ABLE TO ASSIST 13 LOW TO MODERATE INCOME HOMEBUYERS PURCHASE A HOME THROUGH THE DOWNPAYMENT/CLOSING COST ASSISTANCE LOAN PROGRAM. \$100,000 OF THE REVENUE IS PERMANENTLY RESTRICTED TO PROVIDE DOWNPAYMENT ASSISTANCE LOANS TO LOW INCOME FAMILIES.
