1. No less than 50% of proceeds of the Rose Ball will be given to a project of St. Francis Hospital.
2. The 2011 Guidelines recommend that, upon receipt of a completed and approved application, the Greenville Hospital System shall receive a minimum of \$10,000 from the proceeds of the Rose Ball if the amount raised meets or exceeds its projected goal. If the goal is not met, the amount allocated will be reduced by the same percentage applied to all grants.
3. Giving of the funds not awarded to St. Francis Hospital should be awarded using the following percentages (although individual committees may vary these percentages from year to year depending on the Committee's appraisal of the community's needs):
 - a. Arts 10%
 - b. Education 20%
 - c. Environment 10%
 - d. Health and Human Services 60%
4. Funds will be given to specific needs or programs, endowments or capital campaigns and not to general operating expenses of organizations, and to organizations whose direct services benefit individuals in the local community.
5. Preference will be given to programs/organizations that are directed toward basic human needs, such as food/ clothing/shelter, and health care, including preventive programs, such as low-income child care.
6. Preference will be given to programs that are unique rather than duplicative of other programs in the community.
7. No multi-year grants will be awarded.
8. An organization may receive funds if it has been a beneficiary of a previous Rose Ball.
9. In a normal year, no more than 12 gifts will be made, although the Committee may make more grants if they feel a larger number of grants is appropriate or if funding is unusually robust.
10. The Committee may decide to award "mini-grants". If awarded, these grants will be made in amounts of \$5,000 or less to organizations and can be in addition to the grants mentioned in #9 above. The Committee will establish procedures to evaluate these grants.
