THE PALMETTO PROJECT IS A PRIVATE, NON-PROFIT INITIATIVE TO PUT NEW AND CREATIVE IDEAS TO WORK IN SOUTH CAROLINA. LED BY THE BELIEF THAT EVERY PROBLEM FACED BY COMMUNITIES IN OUR STATE IS BEING SOLVED BY SOMEONE SOMEWHERE, WE BRING TOGETHER CITIZENS, CORPORATIONS, AND GOVERNMENTAL AGENCIES TO FIND GOOD IDEAS AND PUT THEM TO WORK STATEWIDE. SINCE WE STARTED IN 1984, WE HAVE BEEN THE CATALYST FOR OVER 100 INNOVATIVE AND CREATIVE PROJECTS. WE ARE NOT A GOVERNMENT AGENCY. WE RELY ON FOUNDATIONS AND CORPORATIONS FOR MUCH OF OUR FUNDING. HOWEVER, OUR STRONGEST SUPPORT COMES FROM THOUSANDS OF INDIVIDUAL SOUTH CAROLINIANS WHO SHARE OUR VISION OF THE STATE’S FUTURE.

	PALMETTO CHILDRENS HEALTH INITIATIVE (PCHI) THIS PROGRAM WAS CREATED AFTER CONGRESS PASSED THE CHILDRENS HEALTH INSURANCE PROGRAM REAUTHORIZATION ACT OF 2009. PALMETTO PROJECT RECEIVED A TWO-YEAR FEDERAL GRANT UNDER THIS ACT TO UNDERWRITE PCHI ACTIVITIES AIMED AT ENROLLING KIDS IN MEDICAID (UP TO 150% OF FEDERAL POVERTY LEVEL) AND THE CHILDREN'S HEALTH INSURANCE PROGRAM (BETWEEN 150% AND 200% OF FEDERAL POVERTY LEVEL). THE GOAL OF THIS PROGRAM SERVICE IS TO ENROLL ALL SC CHILDREN IN ANY HEALTH INSURANCE PROGRAMS FOR WHICH THEY MIGHT BE ELIGIBLE, AND INSURE THAT THEY ARE ASSIGNED TO MEDICAL HOMES.

IN DECEMBER, MORE THAN 2,400 SOUTH CAROLINA FAMILIES WERE ASSISTED WITH GIFTS, FOOD, CLOTHING, AND OTHER SEASONAL NEEDS BY MORE THAN 3,000 DONORS, SPONSOR ORGANIZATIONS AND INDIVIDUALS ACROSS THE STATE. FHF PROVIDES A SYSTEMATIC APPROACH TO REACHING AS MANY OF THE NEEDIEST FAMILIES IN SOUTH CAROLINA AS POSSIBLE. BY COORDINATING WITH LOCAL AGENCIES AND CHARITY PROGRAMS, WE CAN INSURE THAT DONATIONS AND CHARITABLE GIVING ARE TARGETED TO THOSE WHO NEED HELP THE MOST. EVERY DOLLAR DONATED TO FHF GENERATES NEARLY \$9 IN GOODS AND SERVICES FOR PALMETTO STATE FAMILIES IN NEED.

	HEART & SOUL (H&S) THIS PROGRAM IS A STATEWIDE NETWORK THROUGH WHICH VOLUNTEER HEALTH MINISTRIES IN AFRICAN AMERICAN CHURCHES ARE PROFESSIONALLY TRAINED AND EQUIPPED TO EDUCATE, SCREEN, MONITOR, AND REFER-FOR-TREATMENT THEIR MEMBERS AT GREATEST RISK. OUTCOMES INCLUDE LOWER BLOOD PRESSURES THROUGH MORE EFFECTIVE PREVENTION, HEALTH EDUCATION, AND SELF-MANAGEMENT OF RISK FACTORS. OVER A TWO YEAR PERIOD, THE AVERAGE BLOOD PRESSURE OF A H&S PARTICIPANT DECLINED FROM CONSISTENTLY ELEVATED TO NORMAL OVER A TWO-YEAR PERIOD. FIVE YEARS AFTER H&S WAS IMPLEMENTED, STATEWIDE DISPARITIES BY RACE IN CARDIOVASCULAR MORTALITY AMONG MEN DECLINED BY 50%.
