The organization provided a \$1,000 cash scholarship and a laptop computer along with software to 100 graduating high school students planning to attend colleges and universities. The organization also awarded over \$95,000 to nonprofit organizations and established scholarship endowments in the amount of \$370,000 at four historically black colleges and universities.
