**BY-LAWS
OF
SANTEE ELECTRIC TRUST**

ARTICLE I

NAME OF ORGANIZATION

The name of the corporation shall be the
Santee Electric Trust
herein below referred to as
"TRUST"

ARTICLE II

PURPOSE OF ORGANIZATION

The purpose of the TRUST shall be the accumulation and disbursement of funds for charitable purposes in the service area of Santee Electric Cooperative, Inc. Upon dissolution of the TRUST, any remaining funds shall be distributed only for charitable purposes.

ARTICLE III

FUNDING

The TRUST shall be funded by such rules and regulations as may be promulgated by the Board of Directors of Santee Electric Cooperative, Inc. and from any other source of funds available to the said TRUST.

ARTICLE IV

BOARD OF DIRECTORS

The TRUST shall be administered by a nine (9) member Board of Directors composed of one (1) person residing in each district of the Board of Trustees of Santee Electric Cooperative, Inc.

The term of office shall be for a period of three (3) years with one (1) successive term but reappointment may be made to the Trust Board after the lapse of one (1) year. The regular expiration of terms of board members serving with a district shall occur the January following the election for that district seat.

ARTICLE V

QUALIFICATIONS OF BOARD MEMBERSHIP

A board member of the TRUST shall be at least eighteen (18) years of age, a permanent resident of the trustee district from which he is chosen and of good moral character. It shall not be necessary for members of the Board of Directors of the TRUST to be members of Santee Electric Cooperative, Inc. No person seeking or holding a seat on the Board of Directors of Santee Electric Cooperative, Inc. shall remain a member of the TRUST Board.

ARTICLE VI

SELECTION OF BOARD OF DIRECTORS

The initial Board of Directors shall be designated by the Board of Directors of Santee Electric Cooperative, Inc. Thereafter, when vacancies are to be filled or when terms expire, persons shall be named to their respective vacancies on the said Board of Directors by a vote of the Board of Directors of Santee Electric Cooperative, Inc. The existing Board of Directors of the TRUST may make recommendations to the Board of Directors of Santee Electric Cooperative, Inc. ~~for nominees for the TRUST Board.~~

ARTICLE VII

COMPENSATION FOR DIRECTORS

No Director shall receive compensation for serving on the Board of Directors of the TRUST. Such board members may, however, be reimbursed for mileage and out of pocket expenses incurred while on the business of the TRUST when such business is sanctioned by the Board of Directors of said TRUST.

ARTICLE VIII

MEETING OF THE BOARD OF DIRECTORS

A. REGULAR MEETING: The Board of Directors of the TRUST shall meet not less than quarterly at a place designated by the Board. The Board of Directors may meet at such other times as they may deem at their discretion to be necessary.

B. SPECIAL MEETINGS: Special meetings of the Board of Directors may be called by the President or by any three (3) Directors and it shall thereupon be the duty of the Secretary to cause a Notice of such meeting to be given as hereafter provided. The Chairman or Directors calling such meeting shall fix the time and place.

C. NOTICE OF DIRECTORS MEETING: Written notice of the time and place of regular and special meetings of the Board of Directors shall be delivered to members of the Board not less than five (5) days prior thereto, either personally, by mail, or at the direction of the Secretary, and upon default in that duty by the Secretary, then by the Chairman or the Directors calling for such meeting.

ARTICLE IX

QUORUM

A majority of the Board of Directors shall, unless otherwise designated in these Articles, constitute a quorum. In the event that less than a majority of the Board of Directors is present at any meeting, the majority of those Directors present may adjourn the meeting and designate a place and time for the next meeting, under which circumstances the Secretary shall notify the absent members of the place and time of the next meeting. An act of the majority of the Board of Directors present at any meeting at which a quorum is present, and unless otherwise provided in these By-laws, shall be the act of the Board of Directors of the TRUST.

ARTICLE X

REMOVAL OF MEMBER OF BOARD

Any member of the Board of Directors of the TRUST shall automatically cease to be a member of said Board if and in the event such member misses three (3) successive "regular" meetings as outlined in Section "A" of Article VIII of these By-Laws. Any members of the Board of Directors of the TRUST may otherwise be removed for cause from the Board by a two-thirds (2/3) vote of the entire Board of Directors of the TRUST.

ARTICLE XI

OFFICERS OF THE CORPORATION

The officers of the TRUST shall be a Chairman, a Vice Chairman, a Secretary and a Treasurer, and such other officers as may be determined by the Board from time to time. For the purposes of these By-Laws, the above four (4) officers and two (2) elected at-large members shall constitute the Executive Committee of the TRUST.

ARTICLE XII

REVIEW COMMITTEE

The Board of Directors of the TRUST shall appoint a review committee consisting of three (3) of its members plus an alternate to further investigate claims that warrant further review. The member of the Board of Directors of the TRUST that presented the application under investigation shall be a non-voting ex-officio member of the committee. If the presenting member is on the review committee then that member shall serve as an ex-officio and the alternate will replace the presenting member. This committee shall report its recommendations and finding to the Board of Directors of the TRUST.

ARTICLE XIII

ELECTION OF OFFICERS AND TERMS OF OFFICE

The officers shall be selected by ballot elected annually by the Board of Directors at a meeting of the Board of Directors held on an annual basis after the initial organizational meeting.

The terms of office shall be for one (1) year, however, nothing shall prevent an officer from ~~being reelected to consecutive terms of office.~~

ARTICLE XIV

EX-OFFICIO MEMBERS OF BOARD OF DIRECTORS

The President of Santee Electric Cooperative, Inc. or his designee shall be an ex-officio member of the Board of Directors of the TRUST. The TRUST may from time to time have other such ex-officio members as the Board of Directors may in its discretion determine as necessary or prudent.

ARTICLE XV

POLICIES, RULES AND REGULATIONS

The Board of Directors of the TRUST shall have the power to make and adopt such rules and regulations, not inconsistent with the law, the Articles of Incorporation or these By-Laws, as it may deem advisable for the management, administration and regulation of the business and affairs of the TRUST.

ARTICLE XVI

DUTIES OF OFFICERS

A. CHAIRMAN: The Chairman shall be principal executive officer of the TRUST and, unless otherwise determined by the Board of Directors, shall preside at all meetings of the Board of Directors and in general perform all duties incidental to the office of Chairman and such other duties as may be prescribed by the Board of Directors from time to time.

B. VICE CHAIRMAN: In the absence of the Chairman, or in the event of his inability or refusal to act, the Vice Chairman shall perform the duties of the Chairman, and when so acting, shall have all the powers of and be subject to all the restrictions upon the Chairman. The Vice Chairman shall also perform such other duties as from time to time may be assigned to him by the Board of Directors.

C. SECRETARY: The secretary shall be responsible for the keeping of the minutes of the meetings of the members and of the Board of Directors in one or more books provided for that purpose; be responsible for seeing that all notices are duly given in accordance with these By-Laws or as required by Law; be custodian of the corporate records and of the seal of the TRUST and affix the seal of the TRUST to all necessary documents, the execution of which on behalf of the TRUST under its seal is duly authorized in accordance with the provision of these By-Laws; have general charge of the books of the TRUST; be responsible for keeping on file at all times a complete copy of the Articles of Incorporation and By-Laws of the TRUST containing all amendments thereto; and,

in general, perform all duties incidental to the office of the Secretary and such other duties as from time to time may be assigned to him by the Board of Directors.

D TREASURER: The Treasurer shall have charge and custody of and be responsible for all funds and securities of the TRUST; be responsible for the receipt of and the issuance of receipts for monies due and payable to the TRUST from any source whatsoever, and for the deposit of all such monies in the name of the TRUST in such bank or banks as shall be selected in accordance with the provisions of these By-Laws; and in general, perform all the duties incidental to the office of Treasurer and such other duties as from time to time may be assigned to him by the Board of Directors.

ARTICLE XVII

CHECK SIGNING

Any and all checks issued by the TRUST, for any purpose, shall be signed by two (2) officers or one (1) officer and such other person(s) as may be designated by the Board of Directors as having check signing authority.

ARTICLE XVIII

DISBURSEMENT OF FUNDS

Except as otherwise provided by these By-Laws, the Board of Directors of the TRUST shall disclose and explain any personal and/or business interest, connection, kinship, or other association he or she has with the person, family, group, corporation or other entity under consideration for funding by the TRUST.

Such member shall, if requested by the Chairman or any three (3) members of the Board of Directors of the TRUST, excuse himself or herself from the meeting and not participate in the discussion of or voting on the disbursement.

If no request is made that the interested director excuse himself or herself from the meeting, then and in that event, said director may participate in the discussion of the disbursement but shall not vote on the disbursement.

ARTICLE XIX

ACCUMULATION OF FUNDS

Santee Electric Cooperative, Inc. shall transfer funds collected by it for the benefit of the TRUST on a regular basis, but in no event less than quarterly. The TRUST may also solicit and accept contributions from other sources as deemed appropriate by its Board of Directors.

ARTICLE XX

INVESTMENT OF FUNDS

The Board of Directors of the TRUST shall be responsible for the funds entrusted to it and shall make such investment of said funds in a manner which is reasonable and prudent and in keeping with these By-Laws and the policies of the TRUST.

ARTICLE XXI

AMENDMENT OF BY-LAWS

The By-Laws may be altered, amended, or repealed by the Board of Directors of Santee Electric Cooperative, Inc. at any regular meeting of said Board after at least five (5) days notice. The Board of Directors of the TRUST may make advisory recommendations to the Board of Directors of Santee Electric Cooperative, Inc.

ARTICLE XXII

ACCOUNTING SYSTEM & REPORTS

The Board of Directors of the TRUST shall cause to be established and maintained a complete accounting system such that is in keeping with sound financial management and further more the Board of Directors of the TRUST shall make reports to the Board of Directors of Santee Electric Cooperative, Inc. on the operation and expenditures of the TRUST as may be necessary and prudent, but in no case less than annually.

ARTICLE XXIII

POLITICAL CONTRIBUTIONS

No funds of the TRUST shall in any fashion be used to support any candidate for political officer or for any political purpose.

ARTICLE XXIV

BORROWING FUNDS

The TRUST shall **not** have the authority to borrow monies from any bank, savings and loan or other institutions or individuals for any purpose.

ARTICLE XXV

EMERGENCY EXPENDITURE

The Executive Committee of the TRUST by a vote of at least five (5) of its members may from time to time make expenditures on an emergency basis, in accordance with these By-Laws; and policies adopted by the Board of Directors of the TRUST; and in accordance with the purpose of this TRUST, in an amount not exceeding ONE THOUSAND AND NO/100THS (\$1,000.00) DOLLARS, to any person, family, group or organization.

Such emergency expenditure shall be fully disclosed by the Executive Committee at the next regularly called meeting of the Board of Directors of the TRUST.

ARTICLE XXVI

AMOUNT OF EXPENDITURES

Unless otherwise provided by these By-Laws and in keeping with the purpose of this TRUST the Board of Directors of the TRUST may make annual expenditures of TRUST funds by majority vote of members present at a meeting and constituting a quorum according to the following rules:

a.) Not more than TWO THOUSAND FIVE HUNDRED AND NO/100THS (\$2,500.00) DOLLARS, within 12 months to any individual or family unit, group, organization, charity, or like organization.

b.) Not more than TWO THOUSAND FIVE HUNDRED AND NO/100THS (\$2,500.00) DOLLARS nor less than ONE THOUSAND AND NO/100 (\$1,000.00) DOLLARS for members who experience a burn out.

c.) No Round-Up Award shall be made for down payment on a new home except that the Board of Directors of the TRUST shall have the discretion to allocate funds for burn-outs and/or other natural disasters.

d.) That a Round-Up contribution in the amount of FIVE THOUSAND AND NO/100 (\$5,000.00) DOLLARS be awarded twice a year to an agency in each county to assist Santee Electric Cooperative Members with their electricity payments. The designated agencies are as follows:

1. Waccamaw Economic Opportunity Council-Williamsburg County
2. Waccamaw Economic Opportunity Council - Georgetown County
3. Wateree Community Action Agency - Clarendon County
4. Pee Dee Community Action Agency - Florence County

The agencies will use their agency criteria in making the awards.

e.) That a Round Up contribution be made to WIRE (Women Involved In Rural Electrification) in an amount that equals funds raised by WIRE.

f.) No Round-Up awards shall be made for car payments, credit cards, cell phone, child support, car taxes, property taxes, and rental and house payments.

ARTICLE XXVII

RETENTION OF FUNDS

Until such time as there exists a sum of money, including earned interest, in a amount of not less than ONE HUNDRED THOUSAND AND NO/100THS (100,000.00) DOLLARS within the TRUST, no expenditures exceeding ninety-five (95%) percent of the annual contributions, from whatever source derived, may be disbursed or otherwise disposed of for any purpose. Thereafter the Board of Directors of the TRUST may in its discretion and in accordance with other dictates imposed by these By-Laws expend any and all monies, saving and excepting five percent (5%) of the previous years total contributions or FIVE THOUSAND AND NO/100THS (\$5000,00) DOLLARS, whichever is less.

ARTICLE XXVIII

PROXY VOTING

There shall not exist proxy voting at any meeting of the Board of Directors of the TRUST

ARTICLE XXIX

AUDIT

The Board of Directors of the TRUST shall on an annual basis cause the books and records of the TRUST to be audited by a certified public accountant and a report in keeping with sound accounting principles be issued to the Board of Directors of the TRUST and the Board of Directors of Santee Electric Cooperative, Inc.

ARTICLE XXX

FISCAL YEAR

The Fiscal Year of the TRUST shall commence on the 1st day of January of each calendar year and end on the 31st day of December of each calendar year.
