This is accomplished through on-site pet adoptions, transporting animals from other animal organizations in five states (mostly Georgia) to our shelter for adoption, and rescue and rehabilitation of animals from puppy mills, hoarders and dog fighting operations. Over 2,300 canines and felines received spay or neuter services through our high volume, low cost program.
