THE TRUST FUND WAS LARGELY DORMANT DURING 2011. THE BOARD DID NOT MEET AS ALL WERE AGREED TO TRUST FUND EXPENDITURES WHILE THE FUNDS INVESTED IN THE COMMUNITY FOUNDATION OF WESTERN NORTH CAROLINA CONTINUED A GRADUAL RECOVERY FROM THE CRASH OF 2008. THE ONGOING PROGRAMS OF THE TRUST CONTINUED BY THE LIBRARY STAFF. EXAMPLES INCLUDE TUITION REIMBURSEMENTS FOR FULL-TIME STAFF MEMBERS PURSUING THE MASTERS IN LIBRARY AND INFORMATION STUDIES (\$7,681), PURCHASES OF FURNITURE AND EQUIPMENT FOR THE LIBRARIES (\$2,413), PRESCHOOL OUTREACH PROGRAM SUPPLIES AND VOLUNTEER TRAINING (\$671), AND CONTRIBUTION TO THE LIBRARY'S NEWSLETTER (\$975). NO SINGLE GIFTS LARGER THAN \$1,000 WERE RECEIVED.
