The Foundation is the leading organization for awarding scholarships to students and risk professionals. Since 1980, the Foundation has awarded nearly \$4.5M in scholarships, with \$277,500 in scholarships being granted in 2011. In addition, a total of \$125,000 was awarded in Risk Manager in Residence and Student Internship grants. The RIMS ERM grant of \$110,000 was used to create Enterprise and Strategic Risk Management programs that enable risk managers to perform more effectively in the workplace and to add value in their organizations. The focus of the programs developed was having risk professionals acquire the necessary knowledge, skills, and tools in enterprise risk management.

Student involvement programs. This program is designed to provide students with a meaningful internship experience and maximum exposure to risk management and the issues facing today's practitioners.
