THE FOUNDATION FOR FINANCIAL PLANNING PROVIDES FINANCIAL LIFE SKILLS PROGRAM FUNDING TO A VARIETY OF COMMUNITY BASED ORGANIZATIONS THAT ASSIST A VARIETY OF UNDERSERVED GROUPS. RECIPIENTS THEN CONNECT THE PROFESSIONAL FINANCIAL PLANNING COMMUNITY WITH UNDERSERVED POPULATIONS NOT SERVED BY THE PERSONAL FINANCIAL PLANNING MARKETPLACE. THESE POPULATIONS INCLUDE STUDENTS, TEACHERS, ACTIVE AND RESERVE MILITARY AND THEIR FAMILIES, DISASTER VICTIMS, LOW TO MODERATE INCOME INDIVIDUALS AND FAMILIES, THE HOMELESS, SENIOR CITIZENS, NATIVE AMERICANS, FOSTER CARE YOUTH, THE UNEMPLOYED AND ABUSE VICTIMS. THE NEED FOR SOLID EDUCATIONAL NOT PROMOTIONAL FINANCIAL LIFE SKILLS EDUCATION IS STRONGER NOW MORE THAN EVER DUE TO THE RECENT ECONOMIC FLUCTUATIONS. PEOPLE ARE FINDING THEMSELVES UNEMPLOYED, IN FORECLOSURE, DEEP IN DEBT AND THEY ARE SCARED. FINDING TRUSTWORTHY FINANCIAL VOLUNTEERS IS CRUCIAL TO HELPING PEOPLE BEGIN TO CHANGE THEIR BEHAVIOR AND BEGIN TO TAKE CONTROL OF THEIR FINANCIAL LIFE. THE CHALLENGES IN REACHING OUT TO THE UNDERSERVED WITH FINANCIAL LIFE SKILLS EDUCATION IS THE INDIVIDUAL'S PERCEPTION OF THEIR FINANCIAL SITUATION, THEIR AWARENESS AND ACCEPTANCE OF THE FACT THAT THEY NEED HELP, DESTRUCTIVE/SELF-DEFEATING/ UNHEALTHY GENERATIONAL AND CULTURAL FINANCIAL HABITS, THEIR OPENNESS TO DISCUSSING THE SITUATION, AND THEIR COMMITMENT TO CHANGING THEIR BEHAVIOR SO THAT THEY ARE IN CONTROL OF THEIR MONEY. THE SUCCESS OF OUR PROGRAM IN OVERCOMING THESE CHALLENGES IS CREATING A TRUSTING ENVIRONMENT FOR PEOPLE TO TALK ABOUT THEIR FINANCIAL SITUATION BY WORKING WITH COMMUNITY BASED ORGANIZATIONS (CBO) GROUPS WITH WHOM THE UNDERSERVED POPULATION HAS BUILT TRUST. IN ADDITION, THE CBO'S INSIGHT INTO THE GIVEN UNDERSERVED POPULATION CAN HELP GUIDE THE VOLUNTEERS TO GEAR THE FINANCIAL EDUCATION TO THE SPECIFIC NEEDS OF THE AUDIENCE. IN ADDITION, VOLUNTEER TRAINING TO BETTER UNDERSTAND THE SPECIFIC UNDERSERVED POPULATION IS VITAL BECAUSE THE COOKIE CUTTER APPROACH IS NOT SUCCESSFUL. SINCE THE CBO IS PART OF THE ONGOING ACTIVITIES OF THE UNDERSERVED INDIVIDUAL THERE IS A BUILT IN ACCOUNTABILITY TO HELP INDIVIDUALS CHANGE THEIR BEHAVIOR WORKING THROUGH COMMUNITY BASED ORGANIZATIONS THAT KNOW THE NEEDS OF THEIR CONSTITUENTS AND HAVE EARNED THEIR TRUST, WE ARE ABLE TO PRESENT LIFE CHANGING FINANCIAL EDUCATION THAT CAN HELP THEM TAKE CONTROL OF THEIR MONEY INSTEAD OF THEIR MONEY CONTROLLING THEM. IN ADDITION, OUR PROGRAM SUPPORTS TRAINING OF MORE PRO BONO VOLUNTEERS TO ANSWER THE GROWING FINANCIAL LIFE SKILL NEEDS WITHIN THE COUNTRY. THIS CONTINUOUS IMPACT OF OUR OUTREACH IS STRENGTHENED BY OUR PURPOSEFUL SHARING OF BEST PRACTICES AND RESOURCES. BY CONNECTING THE FINANCIAL LIFE SKILLS EDUCATION NEEDS WITHIN THE COMMUNITY WITH THE FINANCIAL EDUCATION RESOURCES, WE ARE CREATING LONG TERM RELATIONSHIPS WHICH WILL OUTLIVE THE SUPPORT OF THE PROGRAM. AS A RESULT, 7,642 FINANCIAL PLANNERS VOLUNTEERED 92,046 HOURS AND HELPED 126,451 INDIVIDUALS. 1,013 CLASSES WERE TAUGHT IN SCHOOLS BY PLANNERS IMPACTING 23,293 STUDENTS. THROUGH THE BOYS AND GIRLS CLUBS THROUGH FAMILY NIGHTS PARENTS JOIN THE KIDS FOR A TIME TO LEARN VITAL FINANCIAL LIFE SKILLS. THE INTER-GENERATIONAL APPROACH COULD BE A KEY TO BREAKING BAD FINANCIAL HABITS THAT HAVE BEEN PASSED DOWN FROM PARENT TO CHILD. WE TRY TO IDENTIFY COMMUNITY ORGANIZATIONS THAT COULD BE PILOTS FOR A PARTICULAR AUDIENCE. AS A VOLUNTEER PLANNER SAID, "PLANNERS CAN BRING THEIR TIME/EFFORT/ EXPERTISE TO GET PEOPLE UP AND RUNNING AGAIN AFTER A DISASTER. BUT IT WAS THE FUNDING OF THE FOUNDATION THAT HELPED CREATE THE INFRASTRUCTURE TO GET HELP TO THOSE IN NEED." THE ABILITY TO CONNECT PEOPLE IN NEED WHETHER FROM A NATURAL DISASTER, DOMESTIC VIOLENCE, MARKET DOWNTURN OR UNEMPLOYMENT, TO VOLUNTEERS THAT ARE EQUIPPED TO HELP THEM REGAIN A REALISTIC PERSPECTIVE AND SIMPLY BEGIN TO MOVE FORWARD WITH A PLAN IS THE CORNERSTONE OF THE FOUNDATION'S GOAL. IN ADDITION TO OUTREACH TO INDIVIDUALS IN NEED, WE HAVE SUPPORTED THE DEVELOPMENT OF NEW OR SPECIALIZED MATERIALS TO MEET THE NEEDS OF SPECIFIC UNDERSERVED POPULATIONS. OTHER EFFORTS HAVE INCLUDED THE CREATION OF NEW DELIVERY APPROACHES THROUGH SPECIFIC AUDIENCES OR LOCALES.
