MHC is open from 1-3PM on Monday, Tuesday, Wednesday, Friday and Saturday. MHC provides 3-4 days' worth of emergency food,
once per month. The exception is the homeless, who are able to come weekly and receive a smaller portion.
Food is obtained through donations of food or money and through the Federal government's TEFAP (The Emergency Food
Assistance Program), which gives us 10,000-15,000 pounds of food the second Wednesday of each month. We are also able to
purchase some food at a good price (18 cents/pound) from the Food Bank when it is available.
We also have quarterly food drives where volunteers ask for donations at local grocery stores.
During 2011 MHC served 27,969 individuals. There were 12,687 families. 6,021 were children under 18; 3,702 were between 55-65
years of age; and 5,234 were over 65. Individuals with no stoves totaled 1,842.
A total of approximately 503,000 pounds of food was distributed to clients in 2011.

In August and September of 2011 MHC assembled backpacks filled with school supplies. The backpacks were donated
to needy food clients with school age children. A total of 120 backpacks was distributed.
