Every year, there is a two-day intensive conference that provides exposure to national experts, leading edge information and opportunities for shared learning with peers. There were 188 Provider attendees, 72 Exhibitors and Sponsors and 25 speakers for these conferences. They are held at various locations around the state. Specific "tracks" relating to particular professional groups or certain areas of the continuum of aging services are addressed regularly during the year through Institute forums and symposiums.

Housed and led the development of the culture change network of Georgia. Received grants to contract with a coordinator, provide training to an array of providers and 50 scholarships to the annual summit.
