2011 Accomplishments

Friends of the Park

Park Pride's Friends of the Park Program aids communities and builds the capacity of neighborhood park advocates by providing tools and resources, technical assistance, fundraising guidance, networking opportunities, access to funding and volunteer support. A Friends of the Park group is formed as a first step in creating positive long lasting change in a public park. A "Friends of the Park" Group is a group of park users (often neighbors & community leaders) actively working to improve one or more parks in a defined geographic area. Park Pride supported 98 community park groups in the City of Atlanta and DeKalb County through the Friends of the Park Program in 2011.

Volunteers

In 2011, Park Pride coordinated more than 5,600 volunteers in 133 group projects—corporate groups, college groups, church and other nonprofit groups. The groups, ranging from six volunteers to more than two hundred accomplished a variety of projects including: invasive removal, spreading mulch, planting gardens, building trails and board walks, etc. These groups provided a total of over 17,000 hours of volunteer service to parks and green spaces in Atlanta and DeKalb County.

Visioning

In January 2011, Park Pride published a Green Infrastructure Vision for the Proctor North Avenue (PNA) Basin, the product of an extensive collaborative process to address the lack of green space in the Vine City and English Avenue neighborhoods. During the year, Park Visioning Plans were completed for Springvale Park, the Outdoor Activity Center and Chosewood Park. Also in 2011, investments of over \$700,000 were made in Adams Park, Herbert Greene Nature Preserve, Little Nancy Creek Park and Orme Park to implement previously completed Park Visions.

Fiscal Partners

In 2011, Park Pride had 41 active Fiscal Partners who raised over \$237,000 for capital improvements to their parks. Fiscal Partners represent a diverse group of park advocates from neighborhoods throughout the City working on a wide range of projects. Partner projects range from a few hundred dollars to cover the cost of materials for a volunteer project to hundreds of thousands of dollars to add new amenities to a park.

Community Gardens

Park Pride's role to help communities establish Community Gardens in City parks began in 2007 and is quickly becoming a popular in areas all across the city. Park Pride assists communities in establishing community gardens in city parks. Through the Community Gardening program, Park Pride connects gardeners to local resources for gardening and provides opportunities for networking.

In 2011, Park Pride provided ongoing support for 20 neighborhood groups and non-profit

organizations who have established community gardens in City of Atlanta parks – including three new gardens built in 2011 at A.D. Williams Park, Selena S. Butler Park, and Welch Street Park.

Annual Parks and Greenspace Conference

More than 300 people, including interested citizens, park professionals, corporate representatives and others attended Park Pride's **10th Annual Parks & Greenspace Conference**. Reflecting the theme for the event "Bridging to the Future", the sessions focused on creative and innovative strategies to address issues facing the parks of today.

Matching Grants

Park Pride awarded more than **\$377,000 in Matching Grants** to support 30 community park improvement projects:

\$15,211 awarded in Community MicroGrants

18 matching grants of up to \$1000 were awarded to communities for park improvement projects.

\$5,000 awarded in Trees in Parks Grants

A matching grant of \$5,000 was awarded to support tree planting in parks. This program is funded through City Tree Recompense Funds.

\$357,000 awarded in Community Grants

Matching grants of up to \$50,000 were awarded to 11 communities for the implementation of large scale park improvement projects.

Adopt-the-Atlanta BeltLine

Through a partnership between Park Pride, the Atlanta BeltLine Partnership, and Atlanta Beltline, Inc., the program provides an opportunity for community member groups, organizations or businesses to "adopt" ¼-mile segments of the Atlanta BeltLine. In 2011, 53 adopter groups participated in the program providing neighbor oversight and other assistance in maintaining areas along the BeltLine.
