Facilitated 51 visiting church mission groups involving 842 people serving in Alaska. Our service included housing, feeding, providing transportation, volunteer hosts, airport transfers, and all management. These groups worked in Anchorage, various remote Native American villages and other towns on the road system. Most of the work was with disadvantaged children and youth -- administering feeding program, games, sports, crafts, Bible school, mentoring. Sponsored week camp for 42 children from disadvantaged homes. Program expenses include team expenses, all vehicle expenses, aviation, office/general, GraceWorks Grandview, and 90% of Scott Kirby salary package including benefits. Revenue includes payments by participants, gifts for aviation, contributions for Scott Kirby, designated gifts for carrying on Alaska work, and reimbursement income.

Facilitated two volunteer teams to Romania involving 43 people. Program expenses include all plane tickets, overseas ground costs, and 10% of Scott Kirby salary package including benefits.
