The Southern Movement Alliance convenes cohorts of participants working in all levels of Southern social justice organizations in order to strengthen movement-wide infrastructure through communication, relationships, and coordinated organizing strategies. Additionally, Project South, Inc. coordinates and facilitates Peoples Movement Assemblies for large groups to participate in a learning and decision-making process to commit to action steps.

The Youth Community Action Program (YCAP) develops youth leadership through popular political education, creates alternative youth-run media programs, and organizes for education justice. The Septima Clark Community Power Institute is a month-long summer leadership development institute for 15-20 high-school aged youth as participants and 3-5 college-aged young people as Action Team Leaders. Youth Speak Truth Radio Program engages 20-30 people aged 13-18 from the Atlanta community to create and produce a 30-minute weekly public affairs program called "Youth Speak Truth" on a community-based radio station. Additionally, youth members initiate Projects for Change to address local community issues including food justice, access to education, and access to childcare.
