The Center hosted 22 workshops on various nonprofit management and governance topics of which 290 people attended. This included the workshops in our Excellence in Action program which is the only nonprofit certification program in the state. The annual Nonprofit Management Conference was also hosted with 130 attendees who attended 19 sessions. In addition to the general workshops, the Center facilitated 29 custom trainings for nonprofits in the areas of board governance and strategic planning. Created and implemented benefits for 345 member organizations including cost-saving subscriptions to grant research engines, nonprofit management publications and other negotiated discounts in insurance, office supplies and website design. Provided informational, referral and technical assistance services to member organizations and over 1,000 other constituents.
