Assistance under this program must be a basic need such as housing, major utility, life sustaining medication or an emergency dental need to ensure they can sustain themselves and eat, and other life necessities that they do not have the means to acquire/replace/resolve on their own. Funds may be used to assist a senior with a one-time crisis after a catastrophic event that allows them to survive. OTHER PROGRAM SERVICES 5. Each activity is a critical component to ensure that no one in the community goes hungry to meet agency objectives of preventing deprivation and suffering. We distribute food, the most fundamental human need, six days a week to residents in need. No homeless person or resident will be denied this basic survival need. Our Surplus Food Pantry consists of breads, desserts, canned or boxed food items, crackers, cookies, and fresh produce as the donor site for the County and participant of the Atlanta Food Bank "Plant a Row for the Hungry", etc. Donations are received from area grocery stores, merchants, gardeners, subdivisions, schools, and churches and caring individuals. Wednesday Noon Day meals are prepared and served by sponsoring groups within the community to ensure that food needs are met. Thanksgiving food boxes provide families in need with a box of donated food and a grocery store card to purchase meat for the holiday, additional special holiday food distributions are provided for Easter, and Christmas. Collaborations within the community and with United Way Forsyth are critical to ensure that adequate resources are on hand to ensure that no one in our community will ever go hungry. Food is the one need we can and do supply to residents on a continuous basis. OTHER PROGRAM SERVICES 6. The thrift store is multifaceted in that it fosters self respect and dignity by providing attractive clothing and household goods through a voucher system for the needy. All items are priced affordably so that almost anyone can afford to acquire their needed items. An Inter Agency Voucher system with School Social workers and the Homeless Liaison since 2006 where they are authorized to issue our store vouchers to ensure that the needs of families and children with identified needs are met. Additionally, the store stores handicap supplies inclusive of wheelchairs, coats, sleeping bags, heaters in the winter, and fans in the summer that are distributed by a voucher from a caseworker based on availability of these items. OTHER PROGRAM SERVICES 7. Other programs for the benefit of needy individuals in the community. Including, but not limited to the Forsyth County Medical Fund-providing life sustaining medicine and limited emergency dental assistance to prevent suffering to residents that do not have insurance or the financial means to acquire on their own.
