4a. The Southeastern Regional Genetics Group, Inc. held its annual meeting July 21-23, 2011, at the Marriott Renaissance Hotel in Asheville, North Carolina. Approximately 154 healthcare professionals with an interest in Genetics attended. Thirty platform and twenty poster presentations were made covering current issues in all areas of genetics: molecular genetics, cytogenetics, biochemical genetics, and clinical genetics. Highlights included collaborative care between specialists and the primary care medical home for children with genetic disorders. training and education of clinical and laboratory geneticists, researching genetic diseases in Puerto Rico, and genomic technologies in personalized medicine. The Consumer Alliance group included a strategy session on funding of medical foods required for patients with metabolic disorders and the concept of medical home patient care and transitioning to adulthood with a metabolic disorder.

4b. Key healthcare providers in the SERGG region (Alabama, Florida, Georgia, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, Puerto Rico and the US Virgin Islands) met on several occasions to continue the work begun in 2004. This included a workgroup meeting on Severe Combined Immunodeficiency (SCID) to discuss how to better diagnose and treat patients with this disorder and several workgroup meeting as well as several meetings throughout the year to develop and design management guidelines outline for healthcare professionals standardized practices on the treatment of patients with inborn errors of metabolism.

4c. SERGG was asked to handle the funds for the International Standards for Cytogenomic Arrays (ISCA) Consortium. ISCA a rapidly growing group of clinical cytogenetics and molecular genetics laboratories committed to improving quality of patient care related to clinical genetic testing using new molecular cytogenetic technologies including array comparative genomic hybridization (aCGH) and quantitative SNP analysis by microarrays or bead chip technology. The First Annual ISCA Consortium Conference was held January 31-February 1, 2011 in Atlanta. Approximately 198 healthcare professionals with an interest in Genetics attended. This group consisted on molecular genetics lab directors, cytogenetics lab directors, genetic counselors, post-doctoral fellows and representatives from industry.
