


The Family & Emergency Services program provides immediate emergency assistance (food, rent/mortgage assistance, utility assistance, clothing, prescriptions, transportation) to the hurting of Central Florida, refers clients to other agencies or governmental programs and works with clients to develop an action plan to improve their long-term situation. Its primary goal is to aid people facing an unexpected financial crisis in maintaining their residence and avoiding homelessness. FES operates out of Downtown Orlando, Ocoee and Winter Park. 12,178 people received direct aid in 2011.

4b (Code) (Expenses \$ 509,820 including grants of \$) (Revenue \$)

Daily Bread serves a free nourishing noontime meal to anyone who is hungry six days every week from two soup kitchens located in Downtown Orlando and in Ocoee (West Orange County). Clothing, legal aid and counseling are also available, as needed, to meet emergency needs for Daily Bread clients. Daily Bread served 174,332 free meals to hungry individuals in Central Florida during 2010. Volunteers donated over 24,000 hours in service at Daily Bread.

4c (Code) (Expenses \$ 151,480 including grants of \$) (Revenue \$)

Fresh Start is a short-term residential program that provides drug-free, sober men the opportunity to rebuild their lives. Its goals are (1) to enable men to move from helplessness to hope, (2) to equip men to acknowledge and strengthen challenge areas, (3) to restore dignity and (4) to monitor progress. Included in the program is an environment of personal growth, job placement assistance, daily meals, counseling, Bible study, clothing and laundry facilities. In 2011, 208 clients spent an average of 125 days at Fresh Start.
