Financial and health programs, and educational scholarships are also provided. The organization focuses its assistance on farmworkers and other rural poor. Farmworkers' Self-Help was founded in 1982 with a mission to educate and empower immigrant Mexican and Mexican-American migrant farmworkers, along with former farmworkers and other oppressed and poverty-entrapped groups in Southwest Florida. Through community organizing, the organization addresses discriminatory and oppressive policies, and practices that adversely affect its community, particularly women and youth.
