Applications are accepted from January 1 through March 31. All materials will be reviewed at the annual meeting of Directors in June and notification of the final decision will be sent in July.

Criteria

In order to be eligible, you must be:

- Applying on behalf of a secondary school
- Applying on behalf of a secondary school located in the United States or one of its territories
- Applying on behalf of a secondary school that has been a member of the National Association of Independent Schools (NAIS) for at least 10 consecutive years
- Applying on behalf of a secondary school that has *not* been awarded a grant by The Benedict Foundation for Independent Schools in the past three years

Grants are not awarded for general operating expenses, debt payments, general endowment, or to individuals. There are no multi-year grants or naming in recognition of the foundation.

APPLICATION PROCESS OVERVIEW



Begin by registering an account during the application period. You will then answer a few preliminary questions, and if you meet the criteria, you will be able to fill out an online

application. Once completed, you will need to submit three additional PDF documents online.

Required PDF Document Uploads

After completing the online application in step 3, you will be required to upload three documents:

1. Letter from Head of School

2. Proposal (limited to 5 pages), which includes:

- Brief history of the school
- Mission statement
- Project description and time period
- Total amount requested
- Anticipated benefits to be derived from the grant

3. Copy of the tax determination letter(s) indicating qualification as a 501(c)(3) organization

Notifications

Notification of the final decision will be sent in July. If awarded a grant, the school is required to send the Foundation a **verification of receipt** of the gift.

Final Follow-Up

A brief final follow-up, signed by the Head of School, on the status of the funded school project is requested by June 1 of the year following receipt of the grant.
