- F. TO DEVELOP POLICIES AND EDUCATIONAL PROGRAMS WHICH AID IN THE PREVENTION OF CRIME.
- G. TO OPERATE FOR THE PROMOTION OF SOCIAL WELFARE BY PROMOTING THE COMMON GOOD AND GENERAL WELFARE OF THE PEOPLE OF BROWARD COUNTY, FLORIDA.
