EARTHQUAKE RELIEF, REPAIR AND REBUILD SCHOOL Under the direction of Architecture for Humanity Rebuilding Center in Port-Au-Prince, Haiti we were able to break ground on Phase One of the reconstruction project for the school. Phase One includes demolition, site work, retaining wall, classroom block and toilet building. Additional funds were used to repair and maintain the temporary classrooms.

OPERATE SCHOOL IN PORT-AU-PRINCE, HAITI School attendance in 2011 was 1235 students. Funding in this area provided classroom materials, 44 teacher and administrator salaries, and utilities. This year we were able to send an extra \$25,000 to purchase new curriculum for each classroom.

PROVIDE DAILY MEALS Meals are provided daily on a rotating basis for 500 students. Approximately 134,500 meals were served each weekday throughout the school year and summer break. We applied for and were approved for meals donated by Feed My Starving Children. Funds were used to ship these donated meals to Haiti where they help offset the cost of the feeding program.
