THE PURPOSE OF THIS POLICY IS TO ESTABLISH GUIDELINES FOR MANAGING A DAILY BREAD ENDOWMENT FUND TO HELP PROVIDE STABLE LONG TERM SUPPORT FOR THE ORGANIZATION'S FACILITIES AND SERVICES. THIS ENDOWMENT FUND WILL BE HELD AND ACCOUNTED FOR INDEPENDENTLY FROM THE ORGANIZATION'S OPERATING AND CAPITAL BUDGETS. THE ENDOWMENT FUND PRINCIPAL MAY NOT BE USED FOR OPERATION OF DAILY BREAD EXCEPT FOR A FINANCIAL CRISIS THAT WOULD OTHERWISE THREATEN THE EXISTENCE OF THE ORGANIZATION. SUCH AN EMERGENCY ALLOCATION WILL REQUIRE A TWO THIRDS VOTE OF A QUORUM OF THE DAILY BREAD BOARD OF DIRECTORS.

IN ORDER FOR THE ENDOWMENT FUND EARNINGS TO PROVIDE SUFFICIENT REVENUES TO HELP SUPPORT OPERATIONS, IT IS

NECESSARY TO HAVE A SIGNIFICANT FUND BASE. FOR THAT REASON, NO ALLOCATION OF EARNINGS SHALL BE MADE FROM THE ENDOWMENT FUND UNTIL SUCH FUND HAS ATTAINED A MINIMUM BALANCE OF \$100,000. WHEN THE MINIMUM FUND BALANCE HAS BEEN ACHIEVED, THE BOARD MAY ALLOCATE UP TO 5% OF THE FUND'S CURRENT MARKET VALUE, DETERMINED AT ITS NOVEMBER MEETING EACH CALENDAR YEAR. THE BOARD MAY DECIDE TO MAKE NO DISTRIBUTIONS FROM THE ENDOWMENT FUND SOME YEARS ALLOWING ALL EARNINGS TO BE REINVESTED WITH THE PRINCIPAL. IN DETERMINING THE AMOUNT TO BE ALLOCATED THE BOARD SHALL CONSIDER THE RECOMMENDATIONS OF THE OFFICERS OF THE BOARD. THE TOTAL VALUE OF THE INVESTMENT, THE IMPACT OF INFLATION AND THE AVAILABILITY OF ALTERNATIVE FUNDING. IT IS THE BOARD'S POLICY TO INVEST THE FUND BALANCE IN A FISCALLY RESPONSIBLE MANNER UNDER THE SUPERVISION OF THE BOARD'S OFFICERS. THE BOARD TREASURER SHALL REPORT AT BOARD MEETINGS ON THE STATUS OF THE ENDOWMENT FUND. IT IS THE INTENT OF THE BOARD TO MINIMIZE COSTS ASSOCIATED WITH FUND RAISING AND ADMINISTRATION OF ENDOWMENT FUNDS.
