Aging and Disability Resource - Establishes a single, coordinated system of information and access to community-based services for seniors and their caregivers.

Home Care for the Elderly (HCE) - Encourages the provision of care for elders age 60 and older in family-type living arrangements in private homes as an alternative to nursing homes or other institutional care. A basic subsidy is provided for support and maintenance of the elderly, including medical costs. A special subsidy may also be provided for additional services and supplies which are needed.

ARRA Chronic Disease Self-Management Program - Provides assistance to those individual affected by the recession through a course to help the elderly with chronic diseases to better manage their own care and live healthier lives.
