The Everglades Foundation was instrumental in developing a new plan to clean up nutrient pollution flowing into the Everglades. The Foundation's scientists developed and proposed a technical plan that the state and federal agencies are planning to construct. The massive \$880 million plan will protect the Everglades and generate construction and engineering jobs. The Foundation was also instrumental in getting the adoption of a streamlined planning process for Everglades restoration projects that will cut the time for the planning from 7 years to 18 months. This will jumpstart efforts build the projects that will re-establish the historical 'River of Grass' flows. The Everglades Foundation has dramatically ramped its very successful Education and Outreach Project. Last year, we
