As part of a pledged gift in 2010 totaling \$10,250,000, the Lightning Foundation received a grant of \$2,000,000 in 2010 and 2011, respectively, which it believes constitutes an unusual grant. The Lightning Foundation made a formal application to the IRS to have the grant deemed an "unusual grant," but at the time of the filing of this 990, formal approval has not been received. The Lightning Foundation has no reason to believe that its application will not be granted.
