Mid Florida Homeless Coalition continues to operate the Mid Florida Information Network, the Homeless Management Information System (HMIS) for Citrus, Hernando, Lake and Sumter Counties. The services provided in 2011 were to continue to educate the community about this system and the benefits it brings to the community. New organizations were added to the system, and the users for these organizations as well as other new users were trained on how to access and use the system. Support of current and new users was also provided. Data was analyzed to ensure data quality and to better understand services being provided, needs of the community and trends in the community. Reports were generated and to submitted to the State and Federal Government as required by local grants. The Revenue reported are dollars raised in the community to meet the match requirement of the Federal grant.

4b (Code:) (Expenses \$ 63297 including grants of \$ 63397) (Revenue \$)

Mid Florida Homeless Coalition applied for the State Challenge Grant on behalf of four organizations. \$59,900 was distributed between four organizations to provide supportive services to individuals and families who once were homeless, had moved into permanent housing, and were in need of supportive services to keep them in housing. 193 unduplicated persons that were comprised of 43 individuals, 43 household with children for a total of 72 children and 6 households without children. The services provided were based on the individual needs of the clients being served. This included such services as rental assistance, property tax assistance, job counseling, life skills, employment, automotive repairs and insurance, case management for all clients served as well many other services. The balance of the funds were used to operate the HMIS for this program.

Part of the mission of our organization is to promote partnerships that will reduce and prevent homelessness. We work within the four counties we serve to provide information and referral connecting people to services. Technical assistance is provided to organizations in an effort to educate and promote increased capacity. This organization provides opportunities for agencies and organizations throughout the four counties to meet, learn about one another, and discover ways to collaborate.
