The sole program and fundamental purpose of the organization is the distribution of food to the hungry. The organization collects, purchases, sorts, packages and distributes food to the needy. In 2011, 1,713 households consisting of 4,176 individuals received a total of 5,293 bags of food. Most of the food was of non-perishable content consisting of canned and boxed items. It was supplemented with meats purchased from Second Harvest (the local food bank) along with fresh vegetables and fruits from a small garden and from donations in kind. Clients are serviced by volunteers, there are no paid staff members. All of our funds are used to purchase food, other then a small amount for utilities and necessary repairs to the building.

New Clients complete an application which asks for name, address, phone #, employer, number of children in home and information on client income and expenses. All new clients are interviewed to confirm information is complete.

Client must provide photo ID cards and social security cards for each person that will be receiving food. Eligibility is determined by comparing the information provided with current government guidelines. Copies of ID and social security cards are attached to application. Food assistance is available every three months. On future visits the information is checked to see if there are any changes and the visits are logged with client signing that they received assistance during the visit. A different volunteer will distribute the food to the client. We work with other local charities and share information with them on what clients are served and they respond in kind. This is done to try to minimize people double dipping in services to allow more people to be serviced (ie receive food today and go to another local charity and get more food).

All of the non-cash donations are food items. This is our major source of donations. Donations are received 1) People drop off food items at our facility; 2) Two major food drives during the year, the boy scouts and the Postal service collect lots of food during these drives and this organization receives a full share; 3) Some churches regularly collect food and bring it to us, others have periodic drives and also bring food to us; and 4) schools and other organizations or clubs periodically also do food drives. During growing seasons we often receive fresh fruits and vegetables from the community. We also maintain a small garden in the Spring and Fall to supplement food provided. Value of the food products is determined by matching typical assortment of food received and pricing it periodically at local supermarkets. Bags of food are put together for a balanced diet and is based upon the number of members in the family or other unit being fed. Almost all of the perishable items are purchased with funds available, mainly at the local food where we can make very reasonable purchases, especially meats. Meats are donated to Second Harvest (food bank) by local stores such as Publix, Winn-Dixie and Walmart. Meats upon their sell by date are frozen and packaged and donated to the food bank. We typically purchase them by the pound for 17 cents a pound and sometimes less. This way we maximize our available resources to provide the most to those in need.
