The community center building has ample common space. This allows island residents to come together informally, as well as for planned social gatherings such as dinners and dances. Cultural and entertainment events including dance and music performances, lectures, films and workshops are also held in the main hall of the community center. These uses of the building provide opportunities for recreational, educational, and healthful social interactions among island residents as well as access to the arts. During 2011 there were three public dances with 121 people attending, 8 showcase events with 609 attending, and 39 family/adult events with 936 attending.

The community center building houses a Fitness Center where a variety of exercise classes are offered, including classes targeted toward older island residents. In addition, exercise equipment is available on a membership basis. Fees are set to cover costs of equipment, and reduced fees/extended payment plans are available for community members needing assistance. Also within the fitness center is a space available for rent by private specialists coming from the mainland to offer physical therapy, counseling, and other services to residents. The availability of health and fitness activities promotes the physical and emotional life of the island residents, particularly during the challenging winter months, providing further support for the year-round community. During 2011 there were 237 scheduled health and fitness offerings, with 989 people attending.

The Zone is the organization's youth program, housed in its own section of the building. The Zone offers air hockey, ping pong, foosball, a pool table, board games, a collection of children's books and a comfortable space to just relax. Dances, sports, movies, summer day camps and other special programs are also offered to the island youth under the auspices of the Zone to help the island retain and attract young year-round families who represent the strength and future of the island community. During 2011, 511 people attended a total of 74 Zone sponsored youth events and offerings.
