Jessamine County cost share on a 50/50 match in 11 investment areas such as cattle handling facilities, farmland improvement, genetics, commodity handling and storage, goats, sheep, agriculture diversification such as bees, greenhouse, grapes, equine, and vegetables. Farmers can invest in technology, dairy, swine, poultry, fencing, and water improvements. There is a \$5000 match limit. Any funds not used must be returned to the Kentucky State Treasury.

4b (Code:) (Expenses \$ 8000 including grants of \$ 8000) (Revenue \$ 200)
Provide grant assistance to local 4H/FFA students in agriculture related projects.
Students can receive up to \$500 for first year agriculture projects. 2nd year applicants can receive up to \$250 and 3rd year students are no longer eligible. Any money not used must be returned to the Kentucky State Treasury.

Received a grant to improve the West Jessamine High School shop. Replaced old equipment and added much needed safety features. Grant received to make improvements so we could offer shop classes to local students as well as adult farmers.
