**RECOVERY SERVICES** (residential recovery and discipleship program for men, transitional living for men and women):  
 Recovery services are designed to help restore lives that have been destroyed through substance abuse. The Life Renewal Program is a one-year residential program that serves men struggling with addictions. Once stabilized, program participants receive six months of intensive education and training. Upon completion, participants focus on vocational goals. In the final phase, participants secure employment and prepare themselves for transition into independent living. From January through July 2011, clients received 1,111 days of service and residential care. (See comments in Schedule O) The Life Renewal Program was superseded by transitional living homes for men and women. Transitional living helps individuals who find themselves homeless for a variety of reasons to temporarily live in a safe, supportive, and accountable home-like setting while they find work, save money, practice healthy living skills, and prepare themselves for moving into permanent housing. From August to December, clients received 874 days of residential care and support at the men's home on High Street. The women's home on Strader Drive was opened at the end of 2011.

**OUTREACH SERVICES** (chapel services, meals and clothes, housing and employment counseling, life skill training, case management, and health clinic services):  
 Outreach Services are designed to help people lead productive and meaningful lives. Relationships and trust are often built through compassionate care. (In 2011, 24,017 meals were served to the hungry, and 686 people were given items of clothing.) People are connected to the resources they need through personal contact with a counselor. (Provided counseling services for 874 people) Health barriers are overcome through access to a free health clinic. (419 patient visits) Life skills are learned through workshops and trainings that focus on managing money, finding and keeping employment, and learning how to use the computer. (873 classroom sessions) A search for jobs and housing is aided by the use of a computer lab and tutors.

**HOMELESS PREVENTION:** (emergency financial assistance for rent, utilities, and other basic needs):  
 Many people have little or no extra money to weather the storm when there is an interruption to income or expenses. Without help, they can easily become homeless. A Housing Counselor meets one-on-one with families to administer financial assistance to families facing a crisis. Rental assistance of \$15,460 was provided to 97 households. Utility assistance of \$10,480 was provided to 89 households. Other assistance was provided for transportation (\$3,429), prescriptions and lab fees (\$3,990), and other varied forms of assistance (\$8,125)

Applications for rent and utility assistance are completed including supporting documentation. Applications are reviewed and approved by a supervisor. The Executive Director approves payments and signs checks made payable directly to the landlord or utility company on behalf of the client. Patient prescriptions are written by the nurse manager and are processed and invoiced through a single pharmacy vendor. Other payments for identification cards, birth certificates, are approved and documented through an application form, which is signed by the requesting staff member and client. Receipts are obtained and attached to the application form. Bus passes and gas cards are purchased in bulk by a supervisor who gives them to an office coordinator who then dispenses them to counselors as they requisition a bus pass or gas card for individual clients by completing an application form. Recovery program participants receive allowances based on the phase of program enrolled. The program director approves the allowances weekly. A check for the total amount is cashed and dispensed by the office coordinator who obtains signatures from the program participants acknowledging their receipt of the funds.

Most of the revenue from the stores are from the sale of used merchandise donated to the organization. (The New Circle Road store was closed on October 31, 2011 due to declining sales). The stores are operated by employees of the mission. Supervised trainees and volunteers supplement the work. Trainees from the residential programs, Urban League, Community Action of Northern Kentucky, Dismass Charities, and Food Stamp office are assigned supervised work at the stores and some are assigned to help the truck driver pick-up larger donated items. Clothing vouchers issued through the Outreach Services Division of the organization are fulfilled at the stores.

Form 990, Part VI, Line 11b: The officers and directors will be sent an electronic copy of the Form 990 a few days in advance of the filing deadline date with instructions to review the form and direct questions and comments to the Executive Director prior to submission.

Form 990, Part VI, Line 12c: Officers, directors, and key employees annually complete a questionnaire that is reviewed by the board to determine the extent, if any, of any real, perceived, or potential conflicts of interest. The board will periodically review and update its Conflict of Interest Policy.

Form 990, Part VI, Line 15a: The Executive Director's compensation is approved by the organization's board each year. Comparable compensation data is reviewed by the Board's Compensation Committee, and the Committee presents its findings and recommendations to the full-board for its approval, which is documented in the Board Minutes.

Form 990, Part VI, Line 19: The organization makes copies of its articles of incorporation, bylaws, conflict of interest policy, and financial statements available upon request. In addition, the most current copy of audited financial statements, Form 990, and Annual Report are posted on the organization's web site. Form, Part III, Line 2: In August 2011, the organization added a transitional home for men at 854 West High Street. The home had a capacity to house 6 clients plus a house coordinator. A women's transitional home (Ruth House), located on Strader Drive, was established in December 2011.

Form, Part III, Line 3: In July 2011, the Life Renewal Program ceased to operate in order to eliminate duplicated services within Lexington, reduce organizational expenses, and provide transitional living services. Also, the New Circle Road Thrift Store was closed at the end of October 2011 to avoid projected financial losses due to scheduled rent increases and declining sales at that location.
