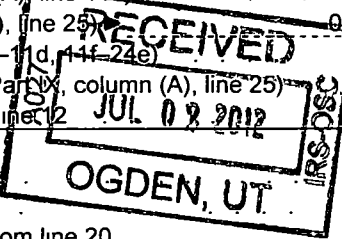

The Princeton Closet either resells donated clothing and household goods or donates these items to other organizations for the needy. In 2011, \$106,000 of these receipts were donated to area charitable organizations, other 501(c)3 organizations, church related organizations and government sponsored programs. Donated clothing, household items and toys are also given at no cost to families and individuals who have suffered from a disaster such as a fire. These people are usually referred to us from local government agencies, American Red Cross and churches. In 2011, 273 vouchers were fulfilled to help individuals and families. Excess donated clothing, shoes and household items are either given to the needy or are eventually sent overseas and distributed to countries in need of clothing items, etc. In 2011, 4,067 bags of clothing and 399 boxes of shoes, belts and purses were shipped overseas. The Princeton Closet has approximately 75 people who volunteer their time on a regular basis to assist in the Closet's mission. (CONTINUED ON SCHEDULE O)
