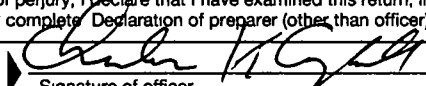

-Water Testing Supplies: UbF purchased water testing supplies for the Uspantan Hospital laboratory in Guatemala. \$937

-Fencing for Xejuyub School: The elementary school of the village of Xejuyub in Uspantan, Guatemala is built on a narrow plateau with steep cliffs on three sides. UbF provided funds for the construction of a fence to improve the safety of the 50 young students. \$3750

- Kitchen for Xejuyub School: In 2007 UbF built an elementary school for the village of Xejuyub in Uspantan, Guatemala. In 2011 UbF provided funding for the addition of a small kitchen so that its 50 students could have improved nutrition. \$5000
