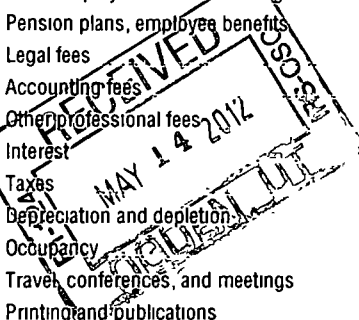

MOVE THE WORLD FOUNDATION

TRUST AGREEMENT effective as of the 22nd day of December, 2011, between **THOMAS L. PAPPAS** (hereinafter called the "Donor"), with a mailing address care of Lynch, Brewer, Hoffman & Fink, LLP, 75 Federal Street, 7th Floor, Boston, MA 02110, and said **THOMAS L. PAPPAS** (hereinafter together with his successors in trust called the "Trustees").

W I T N E S S E T H :

The Donor intends to transfer to the Trustees certain property, and the Trustees declare and agree with the Donor to hold such property and any additional property hereinafter transferred to, and accepted by, them hereunder, IN TRUST, for the purposes, in the manner and with and subject to the powers and provisions set forth herein.

ARTICLE I

This Trust shall be known as **MOVE THE WORLD FOUNDATION**.

ARTICLE II

The Trustees may receive and accept property, whether real, personal, or mixed, by way of gift, bequest, or devise, from any person, firm, trust, or corporation, to be held, administered, and disposed of in accordance with and pursuant to the provisions of this Trust Agreement, but no gift, bequest or devise of any such property shall be received and accepted if it is conditioned or limited in such a manner as to require disposition of the income or its principal to any person or organization other than a "charitable organization" or for other than "charitable purposes" within the meaning of such terms as defined in ARTICLE III of this Trust Agreement, or as shall in the opinion of the Trustees, jeopardize the federal income tax exemption of this Trust pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as now in force or afterwards amended (hereinafter referred to as "the Code").

ARTICLE III

A. The principal and income of all property received and accepted by the Trustees to be administered under this Trust Agreement shall be held in trust by them, and the Trustees may

make payments or distributions from income or principal to or for the use of such charitable organizations, within the meaning of that term as defined in Paragraph C of this ARTICLE III in such amounts and for such charitable purposes as the Trustees shall from time to time select and determine; and the Trustees may make payments or distributions from income or principal, or both, directly for such charitable purposes, within the meaning of that term as defined in Paragraph D of this ARTICLE III in such amounts as the Trustees shall from time to time select and determine without making use of any other charitable organization. The Trustees may also make payments or distributions of all or any part of the income or principal to states, territories, or possessions of the United States, any political subdivision of any of the foregoing, or to the United States or the District of Columbia but only for charitable purposes within the meaning of that term as defined in Paragraph D of this ARTICLE III. The Trustees shall distribute the income for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Code or corresponding provisions of any subsequent federal tax laws. Income or principal derived from contributions by corporations shall be distributed by the Trustees for use solely within the United States or its possessions. No substantial part of the activities of this Trust shall be the carrying on of propaganda, or otherwise attempting, to influence legislation. No part of the activities of this Trust shall be the participation in, or intervention in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office.

B. The Trust shall continue forever unless the Trustees, by unanimous vote, terminate it and distribute all of the principal and income, which action may be taken by the Trustees in their discretion at any time. On such termination, the trust fund as then constituted shall be distributed to or for the use of such charitable organizations, in such amounts and for such charitable purposes as the Trustees shall select and determine. The Donor authorizes and empowers the Trustees to form and organize a nonprofit corporation limited to the uses and purposes provided for in this Trust Agreement, such corporation to be organized under the laws of any state or under the laws of the United States as may be determined by the Trustees; such corporation when organized to have power to administer and control the affairs and property and to carry out the uses, objects and purposes of this Trust. Upon the creation and organization of such corporation, the Trustees are authorized and empowered to convey, transfer, and deliver to such corporation

all the property and assets to which this Trust may be or become entitled. The charter, by-laws, and other provisions for the organization and management of such corporation and its affairs and property shall be such as the Trustees shall determine, consistent with the provisions of this Paragraph.

C. In this Trust Agreement and in any amendments to it, references to "charitable organizations" or "charitable organization" mean corporations, trusts, funds, foundations, or community chests created or organized in the United States or in any of its possessions, whether under the laws of the United States, any state or territory, the District of Columbia, or any possession of the United States, organized and operated exclusively for charitable purposes, no part of the net earnings of which inures or is payable to or for the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting, to influence legislation, and which do not participate or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office. It is intended that the organization described in this Paragraph C shall be entitled to exemption from federal income tax under Section 501(c)(3) of the Code, as now in force or afterwards amended.

D. In this Trust Agreement and in any amendments to it, the term "charitable purposes" shall be limited to and shall include only religious, charitable, scientific, literary, or educational purposes within the meaning of those terms as used in Section 501(c)(3) of the Code.

ARTICLE IV

This Trust Agreement and the Trust hereby created shall be irrevocable and not subject to modification or amendment, except that the Trustees may amend this Trust Agreement any time or times by written instrument or instruments signed and sealed by all of the Trustees, and acknowledged by the Trustees, provided that no amendment shall authorize the Trustees to conduct the affairs of this Trust in any manner or for any purpose contrary to the provisions of Section 501(c)(3) of the Code as now in force or afterwards amended. An amendment to the provisions of this ARTICLE IV (or any amendment to it) shall be valid only if and to the extent that such amendment further restricts the Trustees' amending power. All instruments amending

this Trust Agreement shall be noted upon or kept attached to the executed original of this Trust Agreement held by the Trustees.

ARTICLE V

Any Trustee under this Trust Agreement may, by written instrument, signed and acknowledged, resign said office. Whenever for any reason a vacancy in the office of Trustee occurs, there shall be, and at any other time may be, appointed one or more successor or additional Trustees. Appointments shall be made by the Trustee or Trustees then serving by written instruments signed and acknowledged. Any succeeding or additional Trustee shall upon his acceptance of the office by written instrument signed, and acknowledged, have the same powers, rights and duties, and the same title to the trust estate jointly with the surviving or remaining Trustee or Trustees as if originally appointed.

None of the Trustees shall be required to furnish any bond or surety. None of them shall be responsible or liable for the acts or omissions of any other of the Trustees or of any predecessor or of a custodian, agent, depositary or counsel selected with reasonable care.

The Trustees shall act by majority vote except in those circumstances where unanimous consent is otherwise required under provisions of this trust document and shall have full authority to act even though one or more vacancies may exist. A Trustee may, by appropriate written instrument, delegate all or any part of his powers to another or others of the Trustees for such periods and subject to such conditions as such delegating Trustee may determine.

The Trustees serving under this Trust Agreement are authorized to pay to themselves amounts for reasonable expenses incurred and reasonable compensation for services rendered in the administration of this Trust.

ARTICLE VI

In extension and not in limitation of the common law and statutory powers of Trustees and other powers granted in this Trust Agreement, the Trustees shall have the following discretionary powers:

A. To invest and reinvest the principal and income of the Trust in such property, real, personal, or mixed, and in such manner as they shall deem proper, and from time to time to

change investments as they shall deem advisable; to invest in or retain any stocks, shares, bonds, notes, obligations, or personal or real property (including without limitation any interests in or obligations of any corporation, association, business trust, investment trust, common trust fund, or investment company) although some or all of the property so acquired or retained is of a kind or size which but for this express authority would not be considered proper and although all of the trust funds are invested in the securities of one company. No principal or income, however, shall be loaned, directly or indirectly, to any Trustee or to anyone else, corporate or otherwise, who has at any time made a contribution to this Trust, nor to anyone except on the basis of an adequate interest charge and with adequate security.

B. To sell, lease, or exchange any personal, mixed, or real property, at public auction or by private contract, for such consideration and on such terms as to credit or otherwise, and to make such contracts and enter into such undertakings relating to the trust property, as they consider advisable, whether or not such leases or contracts may extend beyond the duration of the Trust.

C. To borrow money for such periods, at such rates of interest, and upon such terms as the Trustees consider advisable, and as security for such loans to mortgage or pledge any real or personal property with or without power of sale; to acquire or hold any real or personal property, subject to any mortgage or pledge on or of property acquired or held by this Trust.

D. To execute and deliver deeds, assignments, transfers, mortgages, pledges, leases, covenants, contracts, promissory notes, releases, and other instruments, sealed or unsealed, incident to any transaction in which they engage.

E. To alter, repair, or raze buildings or structures; to settle boundary lines and easements and other rights; to partition and join with co-owners and others in dealing with real estate in any way.

F. To vote, to give proxies, to participate in the reorganization, merger or consolidation of any concern, or in the sale, lease, disposition, or distribution of its assets; to join with other security holders in acting through a committee, depositary, voting trusts, or otherwise, and in this connection to delegate authority to such committee, depositary, or Trustees and to deposit

securities with them or transfer securities to them; to pay assessments levied on securities or to exercise subscription rights in respect of securities.

G. To employ a bank or trust company as custodian of any funds or securities and to delegate to it such powers as they deem appropriate; to delegate to any of the Trustees the authority to sign checks on behalf of the Trust; to hold trust property without indication of fiduciary capacity but only in the name of a registered nominee, provided the trust property is at all times identified as such on the books of the Trust; to keep any or all of the trust property or funds in any place or places in the United States of America; to employ clerks, accountants, investment counsel, investment agents, and any special services, and to pay the reasonable compensation and expenses of all such services in addition to the compensation of the Trustees.

H. To pay, compromise, or contest any claim or other matter directly or indirectly affecting the trust fund.


ARTICLE VII

Notwithstanding any other provision herein, no power or authority shall be exercised by the Trustees in any manner or for any purpose which may jeopardize the status of the Trust as an exempt organization under Section 501(c)(3) of the Code and its Regulations as they now exist or as they may be amended; nor shall the Trustees engage in any act of self-dealing as defined in Section 4941(d) of the Code, or corresponding provisions of any subsequent federal tax laws; nor retain any excess business holdings as defined in Section 4943(c) of the Code, or corresponding provisions of any subsequent federal tax laws; nor make any investments in such manner as to incur tax liability under Section 4944 of the Code, or corresponding provisions of any subsequent federal tax laws; nor make any taxable expenditures as defined in Section 4945(d) of the Code, or corresponding provisions of any subsequent federal tax laws.

ARTICLE VIII

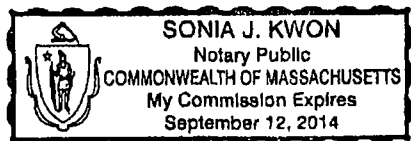
